PROGRAM OVERVIEW & TARGET AUDIENCE

Current Advances in Heart and Vascular Care 2025 will provide the most current, evidence-based strategies for managing cardiovascular disease. The goal is to increase the knowledge of the inter-professional and multidisciplinary care team to provide high-quality, cost-effective care leading to superior and improved patient outcomes.
