PROGRAM OVERVIEW & TARGET AUDIENCE

Kidney transplantation is the kidney replacement therapy of choice for most patients with advanced kidney disease, yet the average wait-time for a patient on the kidney transplant waiting list continues to increase. Over the last several years, allocation changes and national policies have been implemented to increase transplant rates and improve equity and access to transplantation. As the primary referral base, general nephrologists play a key role in patient education and the care of patients before and after transplantation.

The 2019 Advancing American Kidney Health Initiative (AAKHI) sets a goal of doubling kidney transplants by 2030. While transplant nephrologists remain central to the delivery of this care, the shortage of transplant nephrologists and the anticipated growth in the number of kidney recipients will mean that general nephrology providers assume increasing responsibility over these patients within the context of a shared-care model.

This program is intended for general nephrologists and advanced practice providers caring for kidney transplant candidates and recipients. It will address the latest updates in kidney transplantation across the spectrum of care: from kidney transplant candidate referral to wait-listing, transplantation and post-transplant care. A combination of case presentations and lectures will be used to provide an academically sound and clinically relevant review.


LEARNING OBJECTIVES
